We will return to the school at approximately 12:45 am. PLEASE MAKE ARRANGEMENTS TO PICK UP YOUR STUDENT AT 12:45 am...NO STUDENT WILL BE PERMITTED TO WALK OR RIDE A BIKE HOME.
